By July 2016, Bombardier Aerospace set up the C Series Aircraft Limited Partnership (CSALP) with Investissement Québec. On 16 October 2017, Airbus and Bombardier announced that Airbus would acquire a 50.01% majority stake in this partnership, with Bombardier keeping 31% and Investissement Québec 19%, to expand in an estimated market of more than 6,000 new 100- to 150-seat aircraft over 20 years.
