The QBCA, which came into effect in 2011 and modernized Qu bec’s corporate laws, applies to all businesses incorporated under Qu bec law.

QUEBEC Quebec has ordered non-essential stores and services to close until April 13, 2020 with the possibility of an extension as the situation evolves. The directive was made under Quebec’s Public Health Act. The full list of businesses and commercial activities that have been deemed “essential” in Quebec can be found here. It is a shorter list than in Ontario but it is already evolving and may continue to evolve.
