All employers with paid employees working in Oregon must register for a business identification number (BIN) to report and pay Oregon payroll taxes. Corporations without employees must also register to report compensation paid to corporate officers. Oregon uses a Combined Payroll Tax Reporting System to report all payroll taxes together.
