### Section 7 The American R

The legislation was enacted in June 1933 during the Great Depression in the United States as part of President Franklin D. Roosevelt 's New Deal legislative program. Section 7 (a) of the bill, which protected collective bargaining rights for unions, proved contentious (especially in the Senate), but both chambers eventually passed the legislation.

1 U.S. Code § 7. Definition of “marriage” and “spouse”.
